ESCIF Congress and Assembly 2016

The 11th ESCIF Congress and Assembly took place during 11-13 May 2016 in the beautiful city of Vienna. This was the second time that the ESCIF Congress visited Vienna and it was once again organised by the Austrian ESCIF member organisation, Verband der Querschnittgelähmten Österreichs – VQÖ.



The theme of the congress was "Successful Integration after SCI" and what a success the congress was. It is quite clear that the Austrian organisation is professional when it comes to organising congresses as this. We once again want to thank the organising committee lead by Hannes Wiesinger for their excellent work.

The theme took its origin from the Successful Integration Project that is being run by ESCIF. The topics were connected to the focus areas of the project. The programme consisted of an interesting mixture between speakers that in one way or another work within these different fields and the working group leaders from the Successful Integration Project whom presented the groups findings. This set up lead to a high interactivity between professionals and the SCI consumers from the working groups and the audience. The discussions were many and lively.

A very nice start to the programme was of course the guest of honour, Dr. Erwin Buchinger, Ombudsman at the Ministry of Social Affairs in Austria, who talked about social inclusion and social integration. Interesting is that Dr. Erwin Buchinger is the first person to sign the UNCRPD.

The discussions during the Assembly were just as many and lively as they were during the congress. There were many discussions regarding statues, finances and future activities. The Executive wants to thank all the Delegates for contributing to the future of ESCIF. ESCIF has a new member. The Cyprus paraplegic's organisation was accepted by the Assembly. The President of the organisation, Mr. Dimitris Lambrianides, gave us a nice speech about the country, the organisation and the situation for people living with SCI in Cyprus.
