
#### **Dear Colleagues**



# Information-gathering project on MRSA

As we informed you in the January edition of ESCIF Newsletter we intend to launch an information-gathering project on MRSA (Methicillin-resistant Staphylococcus aureus). The reason is that MRSA is fast becoming a problem for the health care system in Europe and all over the world. Having looked into the matter further, we have decided to expand the survey to include the E.coli and Klebsiella since they represent an even greater risk to the SCI population. These bacteria exist everywhere in society and they are rapidly becoming more and more resistant to antibiotics. Persons with SCI are considered as one of the risk groups.

There is no coordination between the health care systems in Europe on how to handle the problem with MRSA and, therefore, the guidelines in the different European countries vary. The Netherlands and the Nordic countries are the most successful countries in preventing MRSA with an incidence rate of 1 %.

The idea behind the information-gathering project is to collect a body of information so that ESCIF can pass this on to people living with SCI and to health professionals working with people with SCI.



## **Nordic Spinal Cord Society (NoSCoS) meeting 2011**



The Nordic Spinal Cord Society (NoSCoS) will hold their biannual meeting in Gothenburg this coming autumn. ESCIF will host a hearing

on the benefits of centralisation of SCI treatment and rehabilitation. The hearing will close the congress and is the only session open both to the congress delegates and the public. We will present the ESCIF policy on centralisation and the findings of the working group. The panel will include a representative from Finland who will describe the process that led up to the recent decision taken by the Finnish parliament to centralise the care for SCI people in the country. ## **Survey on airline policies**



ESCIF has carried out a brief overview in the form of a first round of search on the internet.

The overview shows that every airline observes the rules of the EC and the ACAA. But most companies rely on the safety rules. Under these rules they may require a disabled passenger to travel with an escort or attendant.

A short survey among the members of ESCIF could, perhaps, give us a better insight into how the different airline policies in Europe are implemented. We will consult with EDF to ask for their opinion on REGULATION (EC) No 1107/2006 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL, of 5 July 2006, concerning the rights of disabled persons and persons with reduced mobility when travelling by air. Depending on the answer from EDF we might launch a short survey.
